# 20 Year Limited Warranty:

## Soy-Foam or Latex Mattresses

INDUSTIAS TOBIA, S.A ("Spaldin Sleep Systems") guarantees that your Spaldin Sleep Systems Soy-Foam or Latex Mattress will be replaced or repaired at our option should it be deemed defective due to faulty workmanship or materials, subject to the limitations described in this warranty.

This limited warranty does not include a normal increase in softness of the Soy-Foam material which does not affect the qualities of the mattress.

As part of the performance of the mattress, certain body conformity adaptations will take place as the mattress adapts to your particular body shape and any peculiarities in your spinal alignment.

This warranty covers any deterioration causing the mattress to have a visible indentation greater than three-fourths (0.75) of an inch for those described as memory-soy mattress and 2" for the others, that is not associated with a sag in the foundation or platform or adjustable base.

During the 20 years of this warranty, Spaldin Sleep Systems will, at its option, repair or replace the mattress at a handling cost to be paid by the purchaser.

Spaldin Sleep Systems mattresses are designed to work on a firm, non-spring foundation or a Spaldin Sleep Systems slated bases. This warranty and other performance guarantees are based on tests conducted on "sets" that consist of our mattresses and foundations like these. Therefore, if purchaser uses inappropriate foundations, box springs, or adjustable bed bases with this mattress, such use will void this warranty and all other warranties, whether expressed or implied, including, without limitation, the implied warranties of merchantability and fitness for a particular purpose. Spaldin Sleep Systems may require purchaser to provide proof of the quality of the foundation for the mattress if purchaser makes a claim under this warranty.

If applicable, the ticking cover for the mattress is warranted for 2 years from the date of purchase against faults in material or workmanship. If Spaldin Sleep Systems replaces the cover for the mattress, it will be replaced with the current style of cover available for the mattress, which may be a different color or material than the original cover.

If the mattress, foundation, or cover is physically abused, damaged, burned, cut or torn, this warranty is void.

This warranty is valid only for the original purchaser of the product. An original purchaser is one who purchases the product directly from an authorized retailer of Spaldin Sleep Systems, as indicated in the original sales invoice and registration below. If purchaser is not the original purchaser of this product, he/she takes it "as is" and "with all faults." Proof of purchase will be required to demonstrate that purchaser is the original purchaser and eligible to make a valid claim under this warranty being original invoice the only acceptable proof of purchase.

This warranty gives the purchaser specific legal rights, and the purchaser may also have other rights, which may vary from state to state.

A Spaldin Sleep Systems designated representative or agent shall make the final determination regarding repair or replacement.
